SOUTH CAROLINA ASBESTOS LICENSING

1. Contractor

Fee: \$100.00

- · Issued to companies/individuals who will perform asbestos abatement projects.
- To obtain this license, a company representative must possess a valid SC DHEC supervisor license affiliated with that company. The license is valid for one year from the date the license is processed, providing that a valid supervisor license is maintained.

2. Air Sampler

Fee: \$100.00

- Issued to individuals who will implement air monitoring plans and analysis schemes during abatement. This person is often assigned the duty of acting as the building owner's representative.
- Submit documentation of valid, current training of a SCDHEC approved 1) Asbestos Abatement Supervisor Course or Project Monitor course, and 2) NIOSH 582- Airborne Asbestos Sampling & Evaluation or documentation that the applicant is a Certified Industrial Hygienist. Every year a supervisor refresher course is required to renew this license.

3. Consultant

Fee: \$100.00

- Issued to individuals who will be present an abatement project, but who have not been licensed as a worker, supervisor, building inspector, management planner, or project designer; or is not an authorized visitor.
- Submit documentation of valid, current training of a SCDHEC approved Supervision of Asbestos Abatement training course.

4. Consultant/Building Inspector

Fee: \$100.00

- Issued to individuals who will examine a facility for the presence of asbestos-containing material (ACM), to identify and assess the condition of the material, and to collect bulk samples.
- Submit documentation of valid, current training of a SCDHEC approved Building Inspector course.

5. Consultant/Management Planner

Fee: \$100.00

- Issued to individuals who will interpret inspection reports, conduct hazard assessments of ACM, determine appropriate response actions, develop a schedule for implementing response actions, and prepare written management plans. Individuals possessing a valid management planner license are also authorized to perform the duties of a building inspector.
- Submit documentation of valid, current training of a SCDHEC approved Building Inspector course as well as documentation of valid, current training of a SCDHEC approved Management Planner course. The building inspector course is a prerequisite for receiving training as a management planner.

Consultant/Project Designer

Fee: \$100.00

- Issued to individuals who will plan all phases of an asbestos abatement project design from project site preparation through complete disassembly of all abatement area barriers.
- · Submit documentation of valid, current training of a SCDHEC approved Project Designer course.

7. Supervisor (AHERA)

Fee: \$50.00

- Issued to individuals who will provide direct on-site supervision and guidance to workers engaged in abatement of regulated ACM (RACM). Obtaining this license also authorizes an individual to perform any duties of a Worker.
- Submit documentation of valid, current training of a SCDHEC approved Supervision of Asbestos Abatement Projects course.

8. Worker (AHERA)

Fee: \$10.00

- Issued to individuals who will perform asbestos abatement under the direct guidance of an accredited and licensed supervisor.
- Submit documentation of valid, current training of a SCDHEC approved (AHERA) Worker course.

9. O&M Worker

Fee: \$10.00

- Issued to individuals who will perform asbestos abatement activities on Class III operations and where employees clean up limited amounts of waste and debris from RACM. The amount of material cannot exceed that which can be contained in one glovebag or one 6-mil polyethylene bag measuring no greater than 60 inches in length and width.
- Submit documentation of valid, current training of a SCDHEC approved O & M Asbestos Worker Training course.
 An O & M Worker license shall only be obtained as "company-affiliated".

10. Worker (Roofer)

Fee: \$10.00

- Issued to individuals who will perform abatement on NESHAP-size roofing projects in which the ACM may be rendered friable.
- Submit documentation of valid, current training of a SCDHEC approved Asbestos Roofing Worker course.

11. Supervisor (Roofer)

Fee: \$50.00

- Issued to individuals who will supervise the removal of a NESHAP-size roofing abatement project in which ACM may be rendered friable.
- Submit documentation of valid, current training of a SCDHEC approved Supervision of Asbestos Roofing Projects course.

12. Consultant/Roofing Inspector

Up to 10 people

11 to 20 people

21 to 50 people

51 to 90 people

Fee: \$100.00

- Issued to individuals who will collect bulk samples of roofing products for the purpose of determining whether a material contains asbestos. Materials which are classified as thermal system insulation (TSI) and surfacing materials require the 3 day Building Inspector EPA training of 40 CFR 763.
- Submit documentation of valid, current training of a SCDHEC approved Supervision of Asbestos Roofing Projects course.

13. Group

Fee: The following schedule applies:

\$ 25.00 minimum fee

\$ 2.50 per person

\$ 5.00 per person

\$ 7.50 per person

91 persons or more \$500.00 maximum fee

• Issued to industrial manufacturing and electrical generating facilities and allows facility employees and long-term in-house contractors to perform abatement at the license holder's facility without having to obtain a separate license per employee per category.

• Submit 1) the number of people who will be licensed 2) the name, SSN, discipline, training provider or approved instructor, and examination date of training.

14. Facility O & M

Fee: Same fee schedule as Group licenses

- Issued to non-industrial facilities and allows facility employees to perform limited abatement at the license holder's facility without having to obtain a separate license per employee. Work performed under this license is restricted to the conditions under the O & M Worker license.
- Submit 1) the number of people who will be licensed 2) the name, SSN, O & M training provider or approved instructor, and examination date of training. Work performed under this license is restricted to the conditions under the O &M Worker license.

-All SC DHEC licensing is non-transferable

- -All licenses are issued and restricted based on the training qualifications of the applicant
- -All SCDHEC licenses are valid for one year from the examination date on the training document, except for Contractors, Group, and Facility O & M licenses which may be valid for one year from the issue date on the license -SCDHEC is not responsible for reminding individuals to renew their license
- -In the event that an applicant wishes to transfer from various companies, he/she is advised to obtain a "No Company Affiliation" license
